***UNFINISHED BUSINESS:***

**Bylaws review & approval:**

Mrs. Coker advised that every current member as of December 31, 2009 had received a copy of the bylaws with the proposed changes. She advised most of the changes were language cleanup. She went over some of the changes:

- a. The quorum was changed to 51% of those present at a meeting.
- b. Secretary-Treasurer positions were split.
- c. The dues structure will increase \$5.00 for 2011 with a prorated amount for those joining near the end of the year.
- d. All ex-officio members state the President or their designee.
- e. Executive Board took one position off due to the split of Secretary-Treasurer position.
- f. Nominating committee will submit list of candidates by the end of December each year and annual meeting will be held in February rather than January.

**Motion made by Angela Errett and seconded by Jerry Henderson to approve the bylaws as submitted. Motion carried.**

**President Sharyn Coker appointed Nancy Shobe as the Secretary and Angela Errett as the Treasurer for the 2010 year. All members present approved of the appointment.**

***NEW BUSINESS:***

***Advertising Ideas:***

Mrs. Coker made members present aware of the Exponent Telegram advertising special for March 15 & March 17. The cost for a 2 col. x 5 inch ad running two times would be \$190.00.

Mrs. Henderson also advised the members of an opportunity to join The Shops at 46 Main advertising. Currently The Shops at 46 Main put out a flyer once a month to approximately 100 customers. They have a mailing list of about 500 customers. The flyer lists all the shops located at 46 Main on the left side and featured one business each month on the right side of the flyer. She offered BURMA businesses an opportunity to advertise on the back of the flyer. The cost for postage could be split. Bob Skinner said the idea of direct mailing is right on track. The members ask Mrs. Henderson to bring a sample of the flyer to the next meeting.

Bob Skinner advised of an advertising opportunity on WBOY website at a cost of \$3,000 per year.

Angela Errett said the 2 lane-livin magazine was also another advertising opportunity.

***City Sign Ordinance Feedback:***

Mrs. Coker advised the executive board had approved a response to the city's request for feedback on the sign ordinance. She sent the letter to Rich Clemens, Zoning Officer. The matter will be discussed at the city council meeting 3-4-10.

Angela Errett advised the Strawberry Festival Pageant has been rescheduled for April 11 in order to get more participants.
